WELCOME TO THE ICCD'S 47^H ANNUAL ST. PATRICK'S DAY PARADE

We hope your day will be safe, fun and enjoyable. In order to keep the parade to approximately 1 ½ hours and on pace we ask for your cooperation with the following.

STAGING AREA

- Parade marshals will inform you where to line up. They are in charge of the organization, movement and pace of the parade.
- DO NOT PARK IN THE STAGING AREA between 5th & King St. Only vehicles in the parade are permitted to park in the staging area.
- **BE MINDFUL OF THE LARGE NUMBER OF CHILDREN** needing to be dropped off at the staging area. Non-parade participants and vehicles should not linger in the staging area causing traffic backups and confusion.
- Keep your group together. Move quickly and orderly when your group is called.
- **NO ALCHOLIC BEVERAGES IN THE PARADE LINE-UP AREA OR DURING MARCHING-** this will be enforced by the police. THIS IS A FAMILY EVENT.

MARCHING

- **DO NOT DISTRIBUTE LITERATURE OF ANY KIND OR THROW ANY ITEMS (IE. CANDY) WHILE MARCHING.** This is a safety issue. ******Small children can not be seen** by vehicles in the parade route.
- Keep up with the group in front of you. Keep gaps between groups while marching to a minimal of 20 feet.
- Feel free to perform when the parade stops but be ready to move along when the parade begins moving again. This will avoid large gaps in the parade.
- Limit your performance at the reviewing stand (Rodney Sq.) **to 2 minutes.**

PLEASE adhere to these guidelines in order to make the parade a safe and enjoyable experience for all spectators and especially the groups behind you.
